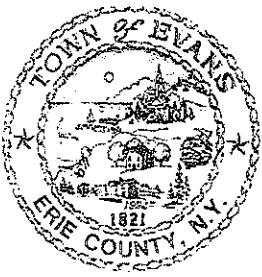



WHEREAS, the Town Board desires to pursue funding opportunities for the following projects, hereafter known as “the Projects”:

2. Rural Transit
