RESOLUTION 2023 #476 Change Order #3 Water Tank and System Improvements

Councilman Schraft moved and Councilman Macko seconded.

Whereas, the Town of Evans (Owner) has a contract with Kandey Company (Contractor) to complete the installation of a new pump station and water storage tank, along with associated water main, along Eden Evans Center Road; and

Whereas, several changes are being proposed to the project including:

- 1. Reduction in quantities related to stormwater and water infrastructure for a credit of \$55,728.67.
- 2. Credit related to the elimination of electrical components related to the pump station in the amount of \$11,941.
- 3. Add in the amount of \$5,302 related to the installation of trees at the pump station.
- 4. Add in the amount of \$5,356 related to the installation of additional underground conduit at the tank site for the main electrical supply.
- 5. Add in the amount of \$9,503 related to additional work at the tank including the extension of the sample tap piping, insulation, and heat tracing.
- 6. Add in the amount of \$5,223.54 related to the installation of additional pressure transmitters at the pump station.

- 7. Add in the amount of \$24,013.02 related to the miscellaneous additional electrical work at the pump station associated with ECWA requirements.
